GENERAL PARKING

Valet parking is expensive and extremely limited at the Loews and Le Merigot Hotels. The AFM encourages attendees to utilize the public parking options available throughout the city. There are over 6,200 parking spaces near the AFM.

Public Parking Rates:

Hourly rates vary at each lot, ranging from \$1 - \$2 per hour with a maximum daily charge of \$9. These lots do not offer in/out privileges.

AFM PARKING PERMIT

Special AFM parking permits have been arranged with the City of Santa Monica for those who require the convenience of in/out privileges.

The AFM Parking Permit is valid Monday, Oct. 31 to Wednesday, Nov. 9

The cost of each permit is \$125.

There will be no refunds or replacements for lost or stolen parking permits.

The AFM Permit is accepted at the following TWO locations:

- Lot 4 South - 2030 Ocean Avenue
- Civic Center Parking Structure - 333 Civic Center Drive at 4th Street

This permit will not be accepted at any other location. No overnight parking is permitted at any public lot.

Shuttle Service: Complimentary shuttle service will be available from the Civic Center Parking Lot and Lot 4 South starting Tuesday, November 1 from 7am to 10pm.
